

Commentary and analysis

Market overview

The FTSE/JSE Capped SWIX Index finished the year on a strong note, rallying 8.2% in Q4 as market participants started pricing aggressive interest rate cuts by central banks in 2024. For the year, it was up 7.9%. Global equities rallied 11.1% in USD largely driven by developed market equities, specifically the eye watering returns of the Magnificent 7. In rand terms, the returns were 3.0% lower as the rand firmed against the US dollar in Q4.

The higher for longer sentiment that ensued in Q3 quickly changed in Q4. As early as in November, market participants started pricing lower interest rates and in December, the US Federal Reserve gave these expectations credibility when it left interest rates unchanged in its final meeting of the year, suggesting that it had hit peak interest rates. On the back of this, financials rallied 12.2% in Q4 and were up 20.0% in 2023.

Domestic industrial companies, after starting the year well (+13.6% in Q1), returned 5.9% in Q4 as Naspers, Prosus and BTI struggled. The technology companies were hurt by the Chinese gaming regulator's decision to announce new rules for gaming companies that are aimed at curtailing gaming use and addiction by players. Tencent share price dropped over 12% on the day, and not surprising, Naspers and Prosus returned 3.7% and 0.7% respectively. BTI lost 6.4% in Q4 (negative 12.0% for the year) after its guidance to impair 25 billion pounds because of its US combustible products.

Local resources also struggled in Q4 and for the year. Lower commodity prices driven by the slowdown in China hurt the sector. In Q4, it returned 3.0% and was down 11.8% for the year. Return dispersion within the sector was unusually high. Gold shares were down 3.4% for the quarter on average but up 52.8% for the year compared to platinum shares which were up 18.8% for the quarter but down 36.4% for the year.

Portfolio review

The fund performed in line with its peer benchmark in Q4 but was significantly ahead of the benchmark in 2023, producing its highest calendar year alpha since we launched it (+5.7%).

The 2023 performance came from the fund's overweight position in global equities. When the regulator gave us allowance to allocate up to 45% offshore in 2022, we took the opportunity to increase exposure to over 30% and this was well rewarded last year as global equities soared 30.3% in rands while the domestic market was only up 7.9%. Peers in the category hold just below 10% offshore and even if one removes the domestic only funds in the category, offshore exposure is about 24%, lower than the fund's 30%.

The domestic component of the fund struggled a bit last year as it was underweight gold companies and overweight technology. Gold companies did well in Q4 as the gold price rose driven by the conflict in the Middle East and expectations that central banks would start cutting interest rates in 2024. Technology companies on the other hand were hurt by the Chinese gaming regulator's decision to announce new rules for gaming companies that are aimed at curtailing gaming use and addiction by players. The global component more than compensated for the poor performance from the domestic component. Sands, Sanders and Veritas contributed the most to the global returns. Sands had 20% in magnificent 7 names – Meta, Microsoft, Alphabet and Apple.

Long term performance is also ahead, in the past 15 years the fund has produced alpha of 1.2% per annum.

Portfolio positioning and outlook

We took some profits from global equities in December, but exposure remains above 30%. In SA, the fund remains underweight resources, specifically gold and platinum companies as managers see value in cheap domestic sectors like retailers. It is overweight Technology with preference for Prosus. Globally, it is overweight financials and underweight technology.

Looking forward – it is now consensus that the US Federal Reserve is done with its hiking cycle and the next move will be a cut, expected as early as March 2024. In 2024, we will be monitoring closely whether the US Fed can manufacture a "soft-landing" for the US economy or whether it succumbs to a recession which has been so widely predicted by the market. While we feel a soft landing is more probable, we are concerned that with 1.5% in interest rate cuts already priced into the US bond market investors may be disappointed if the Fed's expectation of only 0.75% in cuts comes to fruition. Further afield there remain lingering concerns in the Chinese property market and the resurgence of its crackdown on Technology companies meant that companies like Tencent did not participate in the tech frenzy that led to the birth of 'the magnificent 7' label. Any positive news from the regulators would boost the local technology sector.

Given all the uncertainty, panic selling of companies is noticeable in the local bourse and, in such environments, stock picking opportunities open. We trust the managers in the fund to take full advantage of those opportunities.

Unit price – how it works

Prices are calculated and published on each working day, these prices are available on the Manager's website (www.stanlib.com) and in South African printed news media. This portfolio is valued at 24h00. Forward pricing is used. Investments and repurchases will receive the price of the same day if received prior to 15h00.

The payment of withdrawals may be delayed in extraordinary circumstances, when the Manager with the consent of the Fund trustees deems this to be in the interest of all Fund investors. These circumstances may include periods when significant underlying markets suspend trading which will prevent accurate valuation of the instruments held in the Fund. When the suspension of trading relates to only certain assets held by the Fund, these assets may be side-pocketed. This process allows normal liquidity on the assets that can be valued but, will delay liquidity on the affected portion of the Fund. If the Fund is faced with excessive withdrawals, the affected withdrawals may be ring-fenced, which is the separation and delayed sale of the assets reflecting the interest of the liquidity seeking investors. All performance returns and ranking figures quoted are shown in ZAR and are based on data sourced from Morningstar or Statpro and are as at 31 December 2023. Annualised return figures are the compound annualised growth rate (CAGR) calculated from the cumulative return for the period being measured. These annualised returns provide an indication of the annual return achieved over the period had an investment been held for the entire period. The sum of the TER and Transaction Costs is shown as the Total Investment Charge (TIC).

Annual management fee: The Fund charges a fixed annual management fee (i.e. fee class) as a percentage of the assets under management, to ensure a simple and understandable fee structure. The Fund invests primarily in segregated mandates but may also invest in other unit trusts i.e. "Underlying Fund Fees", which are included in the Total Expense Ratio (TER). The annual management fee is accrued daily and paid on a monthly basis.

Advice fees: If an investor appoints an adviser, advice fees are contracted directly between the investor and the adviser. The Manager will facilitate the collection of advice fees only upon receiving an investor's instruction to do so.
